It takes its name from the Trilobite extinct arthropod , which scoured the ocean s floor. The prototype cleaner was first seen on the BBC television programme, Tomorrow s World , in 1997, when it was demonstrated by presenter Philippa Forrester . It was the world s first commercially available autonomous vacuum cleaner, introduced as a product in 2001. The Trilobite contains a vacuum cleaner and a removable roller brush capable of working on deep pile carpet. It has the ability to map rooms and avoid obstacles by using ultrasonic sensor s on the Mark 2 model also infrared . It recharges itself on a charging base, which it automatically finds when has completed its cleaning task or its power runs low. The Trilobite will indicate when the dustbin needs to be emptied. Its ultrasonic sensor s allow it to come within 1 of objects without colliding with them. This object detection is fairly reliable, but sometimes fails if the robot approaches an object with a sharp corner. In this case, the Ultrasound ultrasonic beam is not reflected, and the Trilobite will gently bump into the object. Because the Trilobite stops a short distance from walls and other objects, it leaves small areas that are not fully cleaned. The White line of sewing machines was consolidated into the lower end Husqvarna Viking brand after this sale off. The White Westinghouse brand name remained with Electrolux and that name is the only remnant of the White Sewing Machine Company name, however the brand line included no sewing machines. New White branded sewing machines models have not been manufactured since the Husqvarna spin off in 2006. Husqvarna Viking, Singer, and Pfaff brands are now all owned by SVP Worldwide . Though not advertised, SVP provides all of their user manuals for all of their brands including the White brand through the Singer brand website. The White Motor Company was founded by the same family as a separate company. Pope was originally established as Popes Sprinkler and Irrigation Company in 1925 and after World War II was also a manufacturer of washing machines. Pope also manufactured air conditioning systems. The company changed its name to Simpson Holdings Limited in 1979. Simpson Holdings was a listed public company. In 1986, Simpson merged with Email Limited , an industrial conglomerate specialising in refrigeration, electric meters and metals distribution. In 1999 the Email conglomerate was taken over and broken up with the appliance business being obtained by Electrolux . As of 2006 the Simpson manufacturing plant had been closed down but Electrolux was still using the Simpson brand name on some budget priced products in their range. The Pope brand is still used for some lines of garden watering and sprinkler products.
