1. Range

All offers, services and delivery of coal electric service performed exclusively on the following general conditions applicable at the time of order. Deviations, especially oral agreements and other ancillary agreements, are not effective unless confirmed in writing by us, without such written confirmation is not worth the difference. If any provision of these terms and conditions be or become invalid, this shall not affect the validity of other provisions.

2. Contract

Our offer is - unless otherwise agreed - always non-binding. Just as the customer is binding offer in accordance with § 145 BGB.

3. Prices

Prices at the time of ordering. Prices are, unless otherwise indicated, the gross price with VAT om Signed in euros and are not free, and shipping and handling costs.

4. Payment

Purchase price is due with order. Delivery is done in advance, unless other arrangements are made.

5. Delivery



Deliveries are from stock Elektrokohle services on behalf of the buyer. We have the right at any time from remote locations, for example, delivered directly from the factory, yes.

6. Complaints regarding damage in transit

With transport damage before it was removed and unloading of goods immediately damage survey by mail, lead agent, etc., and obtain a written certificate from Schadensaufnehmenden place.

7. Warranties

The warranty is based on statutory provisions.

8. Cancellation - Return Policy

Consumer contract within a month, without giving reasons in writing (eg letter, fax, e-mail), or - if the goods before the deadline - by returning the goods. Term begins after receipt of this notice in written form, but not before receipt of goods by the recipient (in the case of recurring deliveries of similar goods) before receiving the first partial delivery and not fulfilling their obligations according to § 312c Section 2 BGB in conjunction with § 1 Sections 1, 2 hours before noon to 4 pm BGB InfoV and our obligations in accordance with § 312e Section 1, paragraph 1 BGB in conjunction with BGB § 3-InfoV. Revocation period is sufficient to send the revocation or thing.

In case of cancellation effective mutual benefits received and possibly towed uses (eg interest). Can you give us the performance received whole or in part, or only worsen the situation, you must pay us compensation for the value. With the things this does not apply if the deterioration of the case only on the examit would have been possible in the shop - it is. For the purpose of putting the result of deterioration of thing you have to have value.

Paketversandfähige things are back to our responsibility. You must bear the costs of return, if the delivered goods ordered and if the price returned the case to an amount not to exceed 40 euros or, if you are at a higher price point during the recall or return yet produced agreement agreed partial payment. 10. Packaging
